AUCTION TERMS AND CONDITIONS

Please read the following carefully, as it contains important information on bidding and payment related to the auction. By bidding on an auction item, you agree to be bound by these Terms and Conditions.

On-Site Bidding –

- On-site bidding will open immediately following the end of the Awards Ceremony.
- Bidding will take place via a bid sheet placed immediately next to the subject auction item.
- A minimum bid of \$350.00 OR the amount established by an early bidding commitment, will be in place for each auction item (See Early Bidding). Bidding will be subject to minimum increments as follows:
 - \$50 - Up to and including \$1,000
 - \$100 - \$1,100 to \$3,000
 - \$300 - \$3,300 and up
- Bidders will place their name and phone number on the bid sheet and must be present at the end of the auction in order to claim their item.
- On-site bidding will end promptly at 10:00 PM Pacific Time, Saturday, February 24, 2024

On-Site Payment –

- All items will require payment by the high bidder immediately after the auction ends.
- All items must be paid for via a credit card the night of the auction in order to be released.
- The SOC will collect payment, along with contact information, via a Credit Card Authorization Form.

Early Bidding & Payment –

- The SOC will accept early bids for items through 12:00PM (Noon), Pacific Time, February 23, 2024 at operations@soc.org
- Early bids for an item will require the submission of a completed and signed Credit Card Authorization Form, for the bid amount. The authorization form will be held by the SOC until the completion of the on-site auction and results are known.
- An early bid for an item will represent the dollar amount the bidder is willing and agreeing to pay for the item. An early bid may be advanced once prior to the February 23, 2024 12:00PM Pacific Time deadline.
- The highest early bid on an item at the time of the deadline, will then become/establish the Minimum Bid for that item to begin the bidding at the on-site auction.
- Bidders will be informed when their early bid has established the on-site Minimum Bid for an item.
- The highest early bid that established the on-site Minimum for an item will NOT be advanced by the SOC during the on-site bidding.
- An early bidder can increase their bid only by being present and on-site during the silent auction on 2/24/2024 at the DGA and will be then considered an ‘on-site’ bidder, subject to those terms above.
- An early bidder will be informed of results by Noon, Pacific Time, February 26, 2024 via an e-mail, to include a photograph of the item bid sheet. If the early bid remained the high bid on the item, payment will then be processed against the credit card on file for that amount.
- All winning early bidders will be responsible for costs associated packaging and shipping of items.
